

DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	In FY 2020, Just Add Lime completed two projects for client companies operating mine sites, one in New South Wales, Australia, and one in Queensland, Australia.
	Both projects were focused on managing the client's social/community impact: one was a Social Impact Assessment for a mine expansion, and one was a Needs Assessment to determine the need for expanding accommodations at an existing mine in order to minimise impact on housing affordability in the local community.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	These projects represented ~3% of the company's revenue in FY 2020.
IMPACT ON STAKEHOLDERS	While coal mining is recognised as a controversial industry due to its environmental impact as well social risks related to labor and community impact, Just Add Lime's services to clients in this sector have all been focused on assessing and managing its clients' social impact.
IMPLEMENTED MGT PRACTICES	Just Add Lime has a client screening process in place that includes considering whether the project complies with the company's Code of Ethics. This is done at the 'lead' stage, prior to a proposal being prepared and is part of the 'go-no go' decision for projects. Non-compliance with the Code of Ethics is an automatic 'no-go' for preparing a proposal for a project.
