



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

ISSUE DATE	July 2022
TOPIC	Litigation related to unjustified dismissal
SUMMARY OF ISSUE	Entrepreneur Capital S.L. has had 7 lawsuits filed in the past 6 years by former employees claiming that they were dismissed without justification. Out of 7 total lawsuits, 5 were settled for monetary compensation and 2 lawsuits are pending.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	6 out of a total of 126 employees were affected by the unjustified dismissal, which represents 4.7% of the company's workforce. The total settlements across the 5 settled lawsuits did not exceed 0.2% of the company's total revenue. The settlement value of the pending lawsuits is approximately 0.03% of total revenue.
IMPACT ON STAKEHOLDERS	The 6 employees who each filed the lawsuits were affected in that they were unjustifiably dismissed and did not feel that the associated severance pay was fair.
RESOLUTION	The cases were resolved by the company paying a financial settlement to the plaintiffs.
IMPLEMENTED MGT PRACTICES	The company has adopted some remediation measures in light of the lawsuits. These include – • Follow-up during the probationary period for new hires. • Strengthening of exit processes in cases of disciplinary and objective dismissal. • A process has been designed to gather evidentiary information to support the causes of dismissal in each case.
RELATED INCIDENTS (YES/NO)	Yes, 7 lawsuits were filed by 6 individuals over the same reason.
