This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	Vitasoy International Singapore is a tofu manufacturer, which is a water intensive industry.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Roughly 75% of the company's revenue comes from the sale of tofu products manufactured at its Singapore factory.
IMPACT ON STAKEHOLDERS	As water intensive industries, food & beverage manufacturing poses risks such as water stress or depletion of local water sources if water use is not appropriately managed. The company's water is extracted from the Singapore municipal system. According to the World Resource Institute, Singapore is considered a low water-stressed, low water risk region.
IMPLEMENTED MGT PRACTICES	<p>The company measures water usage per kg of tofu produced. For the past several years, this rate has been:</p> <p>2020: 13.61 L/kg of tofu 2021: 13.75 L/kg of tofu 2022: 12.81 L/kg of tofu</p> <p>The company is targeting a consistent rate of 11.94 L/kg of tofu produced; it has met this target sporadically during certain months.</p> <p>Vitasoy Singapore has implemented the following practices to reduce its water intensity: installed water metering throughout every area of the plant, installed water capture and recycling system to reuse water on non-food contact points (ie. cleaning), and implemented treatment program for the cooling tower water.</p>
