

DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	As a jewelry company, B.P. de Silva Jewellers operates in an industry that relies on materials that pose a risk of human rights infringements and conflict financing. B.P. de Silva Jewellers only sources gemstones, including rough diamonds, through suppliers who hold Kimberley Process Certificates and/or precious metals through suppliers with Responsible Jewellery Council certifications.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	100% of B.P. de Silva Jewellers' revenue comes from the sale of jewelry made from precious metals and gemstones. This includes after sales services.
IMPACT ON STAKEHOLDERS	Companies that use precious metals and/or conflict minerals in their products risk contributing to conflict financing or human rights abuses via their mineral supply chains, particularly in the absence of supply chain traceability and management practices.
IMPLEMENTED MGT PRACTICES	"99% of B.P. de Silva Jewellers' Tier 1 suppliers adhere to a Code of Conduct that includes minimum compliance requirements regarding child labor, forced labor, and conflict minerals, as well as requiring its suppliers to adopt a management system to ensure compliance with the Code. B.P. de Silva Jewellers reviews Code of Conduct compliance and maintenance of relevant certifications (Kimberley Process Certificate and Responsible Jewellery Council Certification) annually. "
