Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

B Lab's Public Complaints Process

Any party may submit a complaint about a current B Corp through B Lab's Public Complaint Process. Grounds for complaint include:

- 1) Intentional misrepresentation of practices, policies, and/or claimed outcomes during the company's certification process
- Breaches of the B Corp Community's core values as expressed in our Declaration of Interdependence

Issue Date	2024
Topic	Penalty related to regulatory compliance
Summary of Issue	In November 2024, the State of Florida Office of Financial Regulation (OFR) issued an administrative complaint against FigTech Inc. following a routine license examination. The complaint alleged certain compliance or licensing issues; however, FigTech disputed the regulator's findings, maintaining that it had not engaged in any wrongdoing.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	As part of the settlement, the company paid a fine of \$20,450, which equals about 1.69 % of its 2024 revenue.
Impact on Stakeholders	The stakeholders impacted are FigTech Inc.'s management and employees, particularly those in compliance and legal roles.
Resolution	To avoid a prolonged dispute, the company opted to settle the matter with the OFR, bringing the case to a close without admitting fault.
Management Practices	FigTech implemented a stronger change management process to ensure all system and policy updates are properly reviewed, approved, and documented. This aims to prevent similar compliance issues from recurring by improving oversight, minimizing human error, and ensuring any operational or regulatory changes are fully assessed before implementation.
