



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

DISCLOSURE QUESTIONNAIRE CATEGORY	Significant layoffs of >20% of workforce
ISSUE DATE	October - December 2019
TOPIC	Significant layoffs due to a decision to reorganize the business model.
SUMMARY OF ISSUE	As of December 2019, Cause laid off four employees. Three of them had been hired as part of a planned expansion to offer additional services that did not prove to be economically viable.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Four employees were laid off, representing 36% of the company's employees at that time (11 employees in total).
IMPACT ON STAKEHOLDER(S)	The layoffs did not have an impact in the relationship with our stakeholders
IMPLEMENTED MGT PRACTICES	The affected employees were laid off in accordance with their contractual obligations.
REPORT	Considering the relative small size of the total number of layoffs, and also considering the nature of the business, we understood that this was not relevant to our main audiences.
OTHER MANAGEMENT COMMENTS	Up until now, all our employees work under contract practices that ensure that, whenever the contract is terminated, the employee is entitled to benefits (paid vacation and 30-day notice).
