

DISCLOSURE MATERIALS

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	B Lab has concluded that providing services to the defense sector has inherent potential risk. The company provided design and delivery website services for one client in the defense sector. The company's business pertained strictly to website-related services and had no involvement in equipment, machinery, or weapons of war.
	Giant Digital Ltd reported that does not have active projects with clients in the Defense Industry. The official client off-boarding was done in July 2023. Since the company no longer earns revenue from this sensitive industry, it was not required to meet B Lab's Risk Requirements for Clients in the Defense Industry.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In 2022, 1.9% of the company's revenue came from the defense sector.
IMPACT ON STAKEHOLDERS	B Lab has concluded that providing services to the defense sector has inherent potential risk; namely ethical implications of these services being used in a way that harms others and/or is misused, a lack of transparency, and other risks pertaining to private sector involvement in activities related to warfare.
