Innovative Support for Underserved/Purpose Driven Enterprises

One of the most innovative aspects of our work has been the development of a proprietary Digital Maturity Assessment and benchmarking framework that transformed how tourism support programmes measure, prioritise, and evidence investment outcomes. When the framework was originally developed for Fáilte Ireland's Digital That Delivers programme, there was no widely adopted, sector-specific methodology capable of measuring the digital maturity of tourism businesses at scale while also linking those insights directly to tailored improvement roadmaps and programme impact measurement. The framework assesses businesses across key pillars including Leadership & Governance, Customer Experience, Operational Capability, Technology, and People, creating a comprehensive view of digital readiness and growth potential. What makes the approach distinctive is that it goes beyond assessment. The data is used to benchmark businesses against their peers, identify capability gaps, generate tailored digital transformation roadmaps, prioritise investment, and measure programme impact over time. This created an evidence-based mechanism for directing public and private investment towards the interventions most likely to improve business performance. The framework has now been applied across more than 600 tourism SMEs through the Digital That Delivers programme, providing a robust dataset on digital capability and enabling the measurement of programme outcomes at both business and sector level. Programme results have demonstrated significant improvements in digital maturity, with reported increases in digital maturity scores and associated commercial benefits across participating businesses. The innovation proved sufficiently successful that it was subsequently productised into the Wheresight Digital Maturity Accelerator (DMA), a scalable SaaS platform now being deployed internationally. The platform enables destination management organisations, tourism boards, and economic development agencies to measure, benchmark, and improve the digital maturity of their business communities using the same evidence-based methodology originally developed for Digital That Delivers. Replicability and industry influence: The model is intentionally replicable, allowing destinations and industry bodies worldwide to adopt a proven framework rather than creating their own from scratch. At the time of its creation, the combination of digital maturity assessment, benchmarking, roadmap generation, and longitudinal impact measurement tailored specifically to tourism SMEs was highly distinctive. Its successful transition from a publicly funded transformation programme into a commercial SaaS platform demonstrates both its uniqueness and its wider applicability. The approach has since attracted interest from destinations across the United States, Europe, the Middle East, and other international markets, validating the model and extending its influence beyond its original Irish context.
