Disclosure Questionnaire Category: Consumer Protection

Topic	Consumer Protection
Summary of Issue	A group of state Attorneys General investigated Adore Me's historical enrollment and cancellation practices with respect to its VIP Membership program. Adore Me reached a global resolution with the participating states' Attorneys General in 2023.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	The settlement represented less than 1% of the total revenues for the fiscal year 2023.
Impact on Stakeholders	The Attorney General alleged that some of Adore Me's historical enrollment and cancellation practices caused customer confusion and Adore Me's unjust enrichment.
Resolution	Adore Me was charged fees and penalties imposed by regulatory agencies. Consumers who were affected by the lack of terms and conditions clarity were entitled to receive a full refund. The company also agreed to implement the following changes proposed by the Federal Trade Commission: 1) Reforming its online marketing practices to ensure consumers understand that they are enrolling in Adore Me's fee-based VIP Membership Program; 2) Obtaining the consumer's express informed consent prior to billing any consumer for Adore Me's VIP Membership Program; 3)Providing consumers with a simple online mechanism to cancel their VIP Membership and promptly stop billing and collecting monthly payments; and 4)Ceasing to charge consumers enrolled in its VIP Membership Program who have accumulated twelve (12) months of store credit. According to Santa Clara County District Attorney's Office (2018), Adore Me cooperated with the investigation and have made changes to their website, automatic renewal notices, and
	their store credit and cancellation practices.
Implemented Management Practices	Adore Me continually evolves its programs to best suit the needs of its customers, and worked in concert with the states' Attorneys General to best serve the customers of the impacted states through changes to Adore Me's user experience and its



	store credit and cancellation practices.
