

DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

DISCLOSURE QUESTIONNAIRE CATEGORY	Significant layoffs of >20% of workforce
ISSUE DATE	Jun-2020
TOPIC	Significant layoffs due to the economic impacts of COVID-19
SUMMARY OF ISSUE	This layoff of three employees occurred in June 2020. The layoffs were in direct response to a revenue loss related to COVID-19. Employees were eligible for rehire and to do contract work on behalf of Beehive. The graphic design employee was allowed to continue using Beehive's Shutterstock subscription. No legal proceedings took place as a result of this decision.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	3 employees were laid off, representing 21% of the company's workforce at that time.
IMPACT ON STAKEHOLDERS	Primary impact was loss of employment for affected employees.
IMPLEMENTED MGT PRACTICES	The agency provided the following assistance to the impacted employees: LinkedIn recommendations, serving as a professional reference, professional networking support, actively supported employee's applications for unemployment, and resume and interview coaching. Employees were allowed to keep their company-issued MacBook Pro laptop as well.
RELATED INCIDENTS (YES/NO)	This has been the only layoff in the company's history within the last 5 years.
