Disclosure Materials

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to a background check by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Disclosure Questionnaire Category: Others - Disclosure Industries

Topic	Clients in Controversial Industries
Summary of Issue	Think HQ is a Communications agency that has had clients in the For-profit higher education and Water utilities industries. The nature of the company's services with clients in these industries has been related to PR and communications, all services can be sold to both controversial as well as non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	The revenue from clients of the For-profit higher education industry represented less than 5% in FY 22-23. The revenue from clients in the Water utilities industry represented less than 5% in FY 22-23.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	Think HQ has a responsible business policy against which all new briefs are assessed which includes exclusions for a range of industries including: • Fossil fuels • Weapons manufacturing • Gambling • Tobacco • Racism and cultural division • Unhealthy foods • Political parties • Alcohol The company carries out a due diligence process with a focus on answering the following questions to ensure their clients align with them on their purpose, and to decide whether to

	progress with a proposal: • Who is the client? • What is their strategy? • Where does their revenue /funding come from? • What is the project’s purpose? • What is the balance of benefits? • What are the relevant issues? The company has a code of conduct but does not require their client to sign anything to demonstrate they will follow their code of conduct.
Management Comments	Think HQ's ensure their projects with higher education and water utilities are assessed against the responsible business policy and have a positive impact. The water utilities clients in Victoria, Australia are government-owned enterprises and the projects focussed on public education campaigns to help people understand the importance of water conservation and encourage them to use limited water resources responsibility.
