



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

TOPIC	California class action lawsuit regarding labeling of Kandoo Flushable Wipes
SUMMARY OF ISSUE	A class action lawsuit filed in 2014 claimed that Kandoo Flushable Wipes manufactured by the Nehemiah Manufacturing Company should not be labeled as "flushable" or "sewer and septic safe." Nehemiah denies that there is any factual or legal basis for Plaintiff's allegations. Nehemiah contends that the labeling of the products was truthful and non-misleading.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	2.9 million packages of the product were included in the class settlement sold between March 2010 and December 2016
IMPACT ON STAKEHOLDERS	Plaintiff's complaint contends that, by marketing the wipes as "flushable" and as "sewer and septic safe," Defendants had caused people to purchase the wipes who would not otherwise have done so.
RESOLUTION	The company and plaintiff agreed to settle the lawsuit in 2017 to avoid the expense and uncertainty of ongoing litigation. Nehemiah contends that all versions of the Kandoo® wipes marketed or sold as "flushable" have indeed been suitable for flushing and compliant with appropriate industry standards.
IMPLEMENTED MGT PRACTICES	Nehemiah agreed to change the composition of the Kandoo wipes, which was in process prior to the litigation. Nehemiah also agreed to remove the phrase "sewer & septic safe" from the packaging.
