



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

TOPIC	Company sources metal precious and gemstones
SUMMARY OF ISSUE	Anna Fine Jewelry is a jewelry retailer and manufacturer whose products utilize precious metals and gemstones. These raw materials could be considered conflict minerals and pose a potential human rights risk.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Approximately 98.60% of the company's Cost of Goods Sold comes from raw materials that would be considered a high risk for human rights violations, including gold, silver, diamonds, and other gemstones.
IMPACT ON STAKEHOLDERS	The use of precious metals and gemstones poses a human rights risk due to the possibility that they are sourced from conflict-affected and high risk areas, where they may be used to finance conflict and/or be associated with human rights abuses in the supply chain.
IMPLEMENTED MGT PRACTICES	<p>All of the precious metal that Anna Fine Jewellery uses is recycled. The company uses either its client's old jewellery or buys it from Cooksongold. Cooksongold is member of the Fairtrade Gold Scheme, Responsible Jewellery Council (member 3763) and Chain of Custody (certification number 3764). In rare cases the company is not able to source recycled metals, it only buys metals that are Fairtrade or Fairmined certified.</p> <p>Anna Fine Jewellery uses recycled diamonds and gemstones from its clients' old jewellerries. When necessary, the company sources coloured gemstones from Nineteen48, which is a Fully Traceable Gemstone supplier. The company also buys lab grown diamonds and other recycled gemstones.</p>
