



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

DISCLOSURE QUESTIONNAIRE CATEGORY	Significant layoffs of >20% of workforce
ISSUE DATE	2017 - 2018 - 2019
TOPIC	Significant layoffs due to business strategies
SUMMARY OF ISSUE	Layoffs were due to elimination of all three I-N brick and mortar stores which were losing business propositions. This adjustment allowed the company to shift support to relaunching and rebranding I-N for long term sustainability including international expansion.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	The closure of all three of the I-N brick and mortar stores resulted in elimination of the majority (16+ staff members) whose primary focus was the daily operations of the stores.
IMPACT ON STAKEHOLDERS	Primary impact was loss of employment for affected employees.
IMPLEMENTED MGT PRACTICES	During retail store closures, company offered severance to full time staff - equal to one week pay per year of service for layoff situations. In addition, select individuals were offered roles as I-N corporate employees where there was a position fit, and in some cases, positions created included advancement and/or growth opportunities.
