Disclosure Questionnaire Category: Other - Clients in Controversial Industries

Topic	Clients in Controversial Industries
Summary of Issue	Bergmeyer is an architectural design company based in the United States. The company has served clients operating in the Alcohol industry as well as the Recreational Marijuana Industry over the last 5 years. Services to these clients has involved master planning, feasibility studies, as well as architectural, interior and graphic design services; all services that can be offered to both clients in controversial as well as non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	Clients operating in the alcohol industry represented 1.03% of the company's FY2023 revenue. Clients operating in the Recreational Marijuana Industry represented 0% of the company FY2023 revenue. Engagement with this industry was through a single engagement in 2020, representing 0.42% of the company's revenue at the time.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	Bergmeyer formally evaluates each client opportunity to ensure the project and the company is aligned with their mission and corporate values before entering into a business relationship. The evaluation of potential clients involves a thorough industry research, a go/no-go discussion and due diligence stages for any potential engagement. Bergmeyer's business decisions are made through the lens of their Code of Ethics and Guiding Principles. Additionally, the company's practices are also done in accordance with the American Institute of Architects (AIA) and the International

	Interior Design Association (IIDA) Codes of Ethics, which make clear their obligations to the Public, Clients, Profession, Colleagues, and to the Environment.

Management Comments	Bergmeyer highlights that the clients they work with in this particular industry are aware of the risks associated with their business and often have their own internal risk mitigation frameworks that are shared with the public.
