Topic	Clients in Controversial Industries
Summary of Issue	2811 is a Colombian based company offering consulting services to organizations involving the installation of capacities and delivery of tools that permit clients to be environmental, economic or social change agents. The company has had a non-profit client in Chile on an on-going basis that aim to positively contribute to communities impacted by the mining operations of the mining company Minera Escondida. The work with this client has involved implementing environmental education and climate action projects through capacity building in agents of change, in educational environments that are part of the area of influence where mining companies operate, seeking to contribute to the development of the region. 2811 has co-created input materials (books, guides) for social entrepreneurs in the development of business models, an initiative of Escondida Mining Foundation and Creo Antofagasta that seeks to strengthen social change for young people in the Antofagasta Region.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In the last fiscal year 5% of the company's revenue was from mining companies.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Management Practices	Currently, 2811 does not have a position on working with clients in controversial industries. The company does not have a due diligence process in place to assess the social, environmental, and governance risks associated with the clients it works with.
