



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	Pulse is a culture change and communications consultancy. Their services include supporting and advising senior leadership teams, corporate communications (internal and external) and creative design. It has clients in the fossil fuel industry.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In 2021, 80% of the company's revenue was associated with clients in the fossil fuel industry.
IMPACT ON STAKEHOLDERS	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
IMPLEMENTED MGT PRACTICES	Pulse offers a range of services to their clients in the fossil fuel industry, including helping leaders navigate the energy transition, stimulating employee culture change and embedding low carbon and safety practices. The company claims to comply with all UK laws and regulations. They are aware of the UK's advertising standards and the Competitions Marketing Authority's guidance. To the best of their knowledge, all their clients comply with relevant legislation in the countries that they operate and are audited accordingly. Pulse has a policy to not work with certain industries, including tobacco, gambling and weapons companies.
