Disclosure Materials

Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Topic	Clients in Controversial Industries
Summary of Issue	The company offers asset rental and sales services to clients in the alcohol industry. The nature of the company's services with clients in this industry has been related to brand activation. All services can be sold to both controversial as well as non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	The revenue from clients in the alcohol industry represented 100% in FY 22-23.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	The company trains their staff in the safe service of alcohol as well as training them to be personal license holders. They also have a dedicated sustainability action plan and are signatories for the Portman Group who uphold the standards within the drinks industry. Special Bar Service and all of their customers support Drink Aware (www.drinkaware.co.uk) which is an independent charity which aims to reduce alcohol related harm by helping people make better choices about their drinking. Drink Aware achieves this by providing impartial, evidence-based information, advice and practical resources; raising awareness of alcohol and its harms and working collaboratively with partners. SBS also adopt a Challenge 25 rather than the required Challenge 21 when they operate any licensed

	retailing.Challenge 25 is a retailing strategy that encourages anyone who is over 18 but looks under 25 to carry acceptable ID (a card bearing the PASS hologram, a photographic driving license or a passport) if they wish to buy alcohol.
