Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

TOPIC	Company's revenue is derived from the sale of animal products.
SUMMARY OF ISSUE	O'Brien Fine Foods (OBFF) produce and package precooked meat products, which includes Pork, Beef, Chicken and Turkey; all OBFF products are animal based. The company sources its Pork and Beef from Irish Processors (Tier 1 suppliers). These processors in turn source the meat from multiple small hold farms (Tier 2 suppliers), that the company does not have direct contact with. OBFF sources its white meat (chicken and turkey) from meat processors across the EU, namely farms and processors in the Netherlands and Germany. In 2023 white meat will also be sourced from Poland, Lithuania as well as Ukraine (Non-EU).
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	96% of the company's supplier expenses are purchases from animal meat processors. Meat processors supply 100% of OBFF meat from small scale farmers across Ireland.
IMPACT ON STAKEHOLDERS	The sale or use of animal products and animal-related services by businesses poses a risk to the humane treatment of animals if adequate management practices are not in place. All of the meat sourced in Ireland is Bord Bia Approved (https://www.bordbia.ie/industry/) - The Bord Bia is Ireland's Food Board and have specific standards required to be kept in order to use their Quality Mark, one of these being animal welfare, which is audited at the Farms and the meat processing sites to ensure the animal welfare standards are maintained. White meat purchased from the Netherlands is aligned to IKB poultry standards and from Germany is aligned to QS poultry Standards.
IMPLEMENTED MGT PRACTICES	OBFF have continued to push the agenda with their Meat Processors, through Annual Questionnaires asking the suppliers to disclose their animal welfare standards when it comes to the transportation and slaughtering of the animals. OBFF works with these during their internal supplier engagement and audits. OBFF also engages continuously with Bord Bia, through the use of the Quality Mark. The company has plans to engage with Bord Bia further, specifically focusing on Animal Welfare and better understanding the role that OBFF can play in supporting higher animal welfare standards within the sector. For OBFF, animal welfare is a key part of its Purpose/Sustainability Agenda going forward.
