

DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

TOPIC	The company works with clients in the nuclear energy industry
SUMMARY OF ISSUE	Brightworks helps clients in different industries establish and implement sustainability programs to increase operational performance and reduce environmental footprints. The company has been involved in work with a public client on its nuclear waste remediation site. The work involved green building and sustainable operations, and recent projects included managing Guiding Principles work, and Commissioning of new spaces. The project work to date has been on ancillary / supporting buildings and transportation. The company has offered sustainability projects with this client over the last 5 years.
"SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)"	Less than 1% of annual revenue is generated through clients in the nuclear energy industry.
IMPACT ON STAKEHOLDER(S)	One of the biggest concerns that the world has with the disposal of nuclear waste is the affect the hazardous materials could have on animals and plant life. Although most of the time the waste is well sealed inside huge drums of steel and concrete, sometimes accidents can happen and leaks can occur.
IMPLEMENTED MGT PRACTICES	"Clients in potentially controversial industries make up a very small percentage of Brightworks's work. Although they don't have a formal written policy with metrics for decision-making, the company mentions they shy away from projects with weapons developers and private prisons. For the controversial industries clients they work with, the company states that the potential work would serve to improve occupant and environmental impacts and not harm. The focus is on improving/optimizing green building performance (energy/carbon reduction, water conservation, resource conservation, occupant comfort/health) of project building developments. The company mentions that there were no financial litigation impacts or penalties/ fines associated with its work with clients in controversial industries, and the main billing type is fixed fee contracts for clients in both controversial and non-controversial industries. Brightworks Sustainability's team offers advanced training and proven expertise. Two-thirds hold advanced degrees in disciplines including mechanical, civil, and environmental engineering; building performance; architecture; environmental policy; natural resource management; and permaculture, among others."
