



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

ISSUE DATE	March 2020
TOPIC	Significant layoffs due to COVID 19
SUMMARY OF ISSUE	The company Ethical Digital, in March 2020, during the COVID19 period, had to lay off 2 employees, which was equivalent to 50% of its total workforce. These employees received help from the Government - CERB (Canada Emergency Response Benefit) and two months later they were hired by other agencies.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	2 employees were laid off, representing 50% of the company's employees at that time.
IMPACT ON STAKEHOLDERS	Primary impact was loss of employment for affected employees.
IMPLEMENTED MGT PRACTICES	The company also provided recommendations wherever possible in order for them to gain re-employment. Both were rehired by other marketing agencies within two months.
MANAGEMENT COMMENTS	After employees were laid off, the organization started getting very busy, and were able to grow again with new employees, as the laid off employees had found gainful employment elsewhere.
