Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

TOPIC	The company serves clients in the alcohol, fossil fuels, nuclear energy and hazardous materials, animal products and services, and prison industries.
SUMMARY OF ISSUE	ARP-Astrance provides services to industries flagged as controversial. The nature of the services provided are the following: • For the alcohol client, the company provides interior design for its offices, • For the fossil fuels client, ARP-Astrance provides interior design for its offices, and provided a study to help them prioritize their petrol stations in terms of actions towards biodiversity based on cartographic analysis of the distance of sites to protected areas, • For the nuclear and hazardous materials industry client, the company provides interior design for several offices and, between 2016 and 2017 ARP-Astrance realized studies in several offices associated with their BREEAM (Building Research Establishment Environmental Assessment Method) strategy and objectives, • The company provided services to an animal protection association, assisting it with its project for new shelters for animals that have been rescued and its environmental quality, • Regarding the prison industry, ARP-Astrance provides project management services of prisons being constructed in France. These new prison structures are part of a governmental plan that targets the increase of capacity and the improvement of the conditions for detainees and premises that participate in a program for the reintegration of detainees into society. The company was hired by the Agence Publique pour l'Immobilier de la Justice (APIJ) - Ministère de la Justice (part of the French Ministry of Justice). On December 2021, B Lab's Standards Advisory Council met and made a decision regarding the eligibility for B Corp Certification of companies supplying to prisons/detention centers. According to the new standards, Certified B Corps supplying to prisons/detention centers and/or utilizing prison/detention center labor will have a grace period of one recertification cycle (i.e., greater than or equal to 3 years) to implement the additional requirements outlined on the updated standards. SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In 2020, 4.29% of the company's annual revenue came from clients in controversial industries.
IMPACT ON STAKEHOLDERS	These controversial industries present a high risk of negatively affecting communities and ecosystems. Therefore, it is best practice that companies have mechanisms in place to ensure that they are not promoting the controversial aspects of these companies.
IMPLEMENTED MGT PRACTICES	 According to ARP-Astrance, the number of clients in controversial industries is limited and the services provided are focused on their real estate and interior spaces with a positive impact on the quality of work or life, Clients from riskier industries are analyzed by the board committee members.
