Disclosure Materials

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Issue Date	2023
Topic	Negative news involving quality assessment conducted in 2017 and brought up in news articles in 2023.
Summary of Issue	<p>Mexico's consumer protection authority, Procuraduría Federal del Consumidor (Profeco) published a quality assessment of rice brands that included the organic rice sold by Aires de Campo. The assessment indicated that the product exceeded the maximum permitted limit of damaged grains under applicable standards, with results showing a proportion significantly above the 2% threshold. Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	As a result of the findings, the company had 15% of its products impacted and 23% of revenue loss.
Impact on Stakeholder(s)	Potential reputational impact on the company.
Implemented Management Practices	<p>Following the quality findings associated with its organic rice, Aires de Campo implemented a series of corrective and preventative measures aimed at addressing classification and supply chain limitations, and strengthening ongoing quality assurance.</p> <p>The initial issue identified in the 2017 assessment related to the absence of proper grade classification, specifically the inability</p>



	<p>of the original producer to meet the requirements of the “Super Extra” grade due to technical constraints in segregating damaged grains. In response, the company initiated the development of a revised product offering beginning in 2016, alongside efforts to align product classification with applicable standards.</p> <p>Given that the product had largely already been distributed and sold at the time the study was published, and that the issue did not relate to food safety or mandatory regulatory thresholds, no product recall was undertaken. There were no legal or regulatory penalties arising from the findings. Instead, mitigation focused on upstream supply chain adjustments.</p> <p>The company undertook efforts to identify and onboard alternative suppliers capable of meeting the required quality specifications. This process was delayed by external factors, including regional production challenges and limited access to milling infrastructure. A new processing arrangement was eventually established with a private mill in the State of Mexico, enabling improved control over processing and polishing stages, followed by organic certification.</p> <p>In 2018, the company obtained organic certification through Mayacert, an accredited body approved by SENASICA, supporting compliance with relevant agricultural and quality standards. Product labelling was also revised to accurately reflect the “Super Extra” classification in line with the parameters referenced in the Profeco study.</p> <p>Ongoing management practices include continued collaboration with suppliers, particularly in Morelos, through consulting and training initiatives focused on quality control and food safety. The company also conducts periodic product analyses to verify compliance with applicable standards and to ensure that current inventory meets the expected quality thresholds.</p>
