Disclosure Questionnaire Statement

Disclosure Questionnaire Category: Other - Disclosure Industries

Topic	Clients in Controversial Industries
Summary of Issue	Wild Visual Communications designs and produces branding materials. The company has had clients from the Alcohol and Tobacco (vaping devices/oral nicotine) industry which are deemed controversial by B Lab. The services provided to the clients include installing the signage and wayfinding for an event at the client's distilleries, designed and produced branded spaces and providing décor for a stand space at the client's event. The services provided to the clients can be sold to other clients in different industries, including other both non-controversial and controversial industries, although it is tailored from client/industry to client/industry.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In the fiscal year end of 2023, the company had generated 15% of its total revenue from clients in the alcohol industry and 7% from clients in the tobacco industry.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	Wild does not directly work with clients in the tobacco industry. The services provided for the clients in the tobacco industry were through 3rd parties. By September 2024 the company will no longer provide any services to the tobacco industry directly or via 3rd parties. For the alcohol industry, Wild does not currently, and will not in the future, provide support of services for the direct sale or

	promotion of alcohol. The company intends to limit its services for clients in the alcohol industry through supporting 3rd parties in the delivery of heritage projects (i.e. museum style experiences at distilleries etc.). Any project that may be deemed controversial or in any way against the company's ethical position will be referred to an internal review by a panel of 3 leaders within the business. They will then assess the project for it's ethical alignment with Wild's ideals, this will include a review of the projects intentions, the impact on local society both socially and economically, and the environmental impact also. If deemed to not meet the company's standards, or in any way make the team feel uneasy about its association with the project, it will be politely declined.
