

DISCLOSURE MATERIALS

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

TOPIC	Significant layoffs due to closing of marketing agency, GOOD
SUMMARY OF ISSUE	Due to political unrest in Chile in late 2019 and a subsequent economic downturn/ challenges with participating businesses, Birus discontinued the branch of their work focused on marketing, called GOOD, and laid off several employees.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Of the original 7 employees, 6 were laid off and at the same time 2 of the 3 consultants were laid off as well which means that 90% of the workforce were laid off at once.
IMPACT ON STAKEHOLDER(S)	The primary stakeholder impact was loss of employment for several GOOD employees and consultants.
IMPLEMENTED MGT PRACTICES	Birus worked closely with each individual to assess how the company could best support them. The two consultants were paid some type of severance while also being allowed to take their clients with them to their new jobs. The employees of the marketing agency, GOOD, were not paid severance, but were supported through job search assistance and the freedom to leave their contracts early upon securing new employment.
