Summary of Issue	Ship2B Ventures SGEIC SA is a company that provides equity investment opportunities to its clients. The company has provided investment opportunities in these funds for client(s) in controversial industries such as Oil Sands, Natural gas, Coal, and Fracking industries. The company operates a fund in which is geared toward funding social and environmental impacts, of which the client has invested in, and will receive expected returns, those returns are speculated by the company to be reinvested in the fund however the company has no control over the client and what it does with the returns on investment which then has the possibility to grow the fossil fuel industry in ways that is harmful to the environment. The company does not have any guardrails or management practices to mitigate the client(s)' harmful impacts for operating in the fossil fuel sector. The fund the company operates is open to other investors from any background.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	2.73% of the client revenue comes from client(s) in the Oil Sands, Natural gas, Coal, and Fracking industries. The relationship between the client and company is ongoing. The company charges a flat rate for services across all clients.
Impact on Stakeholders	Companies that offer products/services to clients in controversial industries may be contributing to the controversial impact of those industries. In this circumstance wealth building for the industry, that has a potential to grow the fossil fuel industry, which leads to additional CO2 emissions which have been proven to affect drastic climate change.
Management Practices	The company does not conduct any ESG screening of their clients, and currently does not receive funding from any other controversial industries that B Lab has identified . The company does not have a list of industries that are banned from being a client. The company has not set any ESG targets for clients.
