Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Topic	Clients in Controversial Industries
Summary of Issue	AdvantiKA GmbH is a sustainability consulting firm that provides services to clients in non-controversial industries, although some controversial industries, such as pharmaceuticals and tax advisory services, figure as customers of AdvantiKA as well.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	For the fiscal year 2023, the revenue generated from clients in controversial industries accounted for approximately 21.8% of the company's overall revenue: • 21.8% of the client revenue has been from clients in the pharmaceutical industry. During 2023, the company did not generate any revenue from clients in the tax advisory services industry.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact on stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue, and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	The company aims to collaborate with organizations that are dedicated to sustainable and responsible business practices. The company avoids working with sectors such as firearms, tobacco, and genetically modified organisms (GMOs), as well as companies with human rights violations or those known to have infringed upon civil rights. The company assesses potential clients through interviews to ensure transparency and to understand their sustainability intentions. Additionally, it reviews publicly available information to gain insights into the client's operations.

Management Comments	Our client in the pharmaceutical industry also works with natural cosmetics and focuses on anthroposophical pharmaceuticals. AdvantiKA GmbH collaborates with companies to reduce and mitigate their negative impacts while enhancing their positive contributions. Our services are designed to help organizations adopt more sustainable and responsible approaches, such as meeting ESG obligations, achieving B Corp certification, or developing business models that prioritize positive outcomes for people and the planet. Therefore, contrary to the statement in the Impact above, our actions have a positive effect on stakeholders rather than causing harm.
