SUMMARY OF ISSUE	Reestlandhoeve is a vineyard and care farm that produces, sells, and distributes alcohol products.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In the previous fiscal year, 50% of Wijngoed en Zorghoeve de Reestlandhoeve's revenue was earned from the sale of alcohol products.
IMPACT ON STAKEHOLDERS	Alcohol may have a negative impact on the health and well-being of individuals and their communities
IMPLEMENTED MGT PRACTICES	The company complies with all regulations and laws related to the sale of alcohol in the jurisdictions where it operates. In addition, the company's employees have completed trainings related to compliance with the relevant regulations. Also, the company has partnered up with Wine in Moderation, which is a platform that educates stakeholders about responsible alcohol consumption.

TOPIC	Biodiversity Impact and Monoculture Agriculture
SUMMARY OF ISSUE	As a vineyard and winery, Reestkandhoeve operates in an industry in which biodiversity impact and monoculture agriculture are material environmental issues.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In the previous fiscal year, 50% of the company's revenue was earned from the sale of wine
	Around 85% of the land under the company's control is cultivated as a vineyard. The uncultivated land, which corresponds to 15%, is kept diverse with grass, hedges, trees, and water 2,7 hectares of the vineyards were planted in 2003 and 0,3 hectare was planted in 2018. Since vines are perennial crops, there will not be active planting every season.
IMPACT ON STAKEHOLDERS	Agriculture, particularly in cases where a single crop is cultivated at a time, poses a risk to local ecosystems of flora and fauna as well as the potential degradation of cultivated land.
IMPLEMENTED MGT PRACTICES	 The company has some practices in place to preserve the biodiversity in the land, such as having insect hotels, ponds, hedges, field edge flowers, and permanent shelterbelts, Because of the perennial character of the vineyard, there is no crop rotation possible. The degradation of the land around the vines is minimized by keeping the rows between the vines with a permanent grass and herb mixture, To keep the vineyard healthy and prevent to take drastic measures such as using pesticides, the Reestlandhoeve successfully uses a variety of homeopathic remedies to keep the vineyard healthy, strong and keep diseases and fungi out of the crop. The Reestlandhoeve uses no chemical fertilizers, only organic manure and additives are being used in the vineyard, For 2025, the company aims to double the green areas inside and surrounding its land, Reestlandhoeve is planning to invest in restoring elements of the former landscape.
OTHER MANAGEMENT COMMENTS	The company emphasizes the use of homeopathic techniques for pest control, on which the results obtained in organic crops are being studied, identifying the points of the harvest in which they affect the crops; as well as the appearance of new fungi and viruses, due to climate change.

TOPIC	Water Intensive Industries
SUMMARY OF ISSUE	As a vineyard and winery, Wijngoed en Zorghoeve de Reestlandhoeve operates in an industry that is water intensive. Aspects of the industry that make it water intensive include irrigation used in the cultivation of vines, water used in the winemaking process (e.g. for cleaning tanks and barrels), and water used in the bottling process.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In the previous fiscal year, 50% of the company's revenue was earned from the sale of wine.
IMPACT ON STAKEHOLDERS	As water-intensive industries, agriculture and wine production pose risks such as water stress or depletion of local water sources if water use is not appropriately managed. The company uses tap and groundwater, which is also the source of supply for local communities. Therefore, using this water source may imply a greater demand for the resource, as well as a possible limitation of access to local communities in dry seasons.
IMPLEMENTED MGT PRACTICES	 The company's vineyard doesn't need irrigation because the roots grow in the groundwater, Recently, Wijngoed en Zorghoeve de Reestlandhoeve started measuring its water consumption (tap and groundwater), The company does not have reduction targets yet.
OTHER MANAGEMENT COMMENTS	The company differentiates the water sources it uses, depending on the type of use. It has its own well (100 m deep), and uses spring water for flushing the toilets instead of tap water, which often comes from groundwater (in the Netherlands tap water comes from 25 m deep). During the dry season in the Netherlands, farmers can't irrigate with groundwater. There isn't a limitation on springwater in the Netherlands yet because they aren't disrupting the water source for its local communities. Results of the re-routing are a yearly reduction of: 91.000 L water tap water.
