



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	As a chocolate manufacturer, Rio Nuevo Chocolate operates in an industry in which human rights issues such as forced labor, child labor, and human trafficking are prevalent globally in the cocoa supply chain.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Approximately 86% of supplier expenses come directly from two cocoa farms. The company sources from two farming communities in Ecuador and 100% of the cocoa beans they source are traceable back to the these two communities. The company maintains direct contact with both communities.
IMPACT ON STAKEHOLDERS	The global cocoa industry has a history of forced and child labor, which subjects workers to poor working conditions, low wages, and puts children at risk for human trafficking.
IMPLEMENTED MGT PRACTICES	<p>All of the company farmer partners own small farms and although they farm in traditional and chemical free methods, they do not yet hold any certifications. The company is working together with their farmer partners in Ecuador to achieve some certifications in the near future.</p> <p>The company has a public formal statement against child labour available in their website and a another one that is shared with suppliers. The company is 100% confident that there is no slave labour or child labour practices in their supply chain, as they work alongside non governmental organisation that work directly with the farmers, and carry out educational and community led development projects. These projects ensure that the farmers employ safe and fair working conditions if they employ any outside help. The company also carries out regular visits to the farmers.</p>

OTHER MANAGEMENT COMMENTS	In the last 20 years great progress has been made and Ecuador has taken significant strides forward in eradicating harmful child labour from farms. There have been encouraging advances. It's now rare to find child labourers on farms. The new code for children and adolescents raised the legal age of employment, increased penalties against employers and prohibited children from working in dangerous environments.
