Disclosure Questionnaire Category: Significant layoffs of >20% of workforce

Issue Date	November 2019
Topic	Significant layoffs due to unforeseen manufacturing challenges.
Summary of Issue	The company faced unforeseen manufacturing challenges bringing its initial products to market: this delayed launch and associated revenue generation.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	4 employees were laid off, representing 66% of the company's employees at that time.
Impact on Stakeholders	Primary impact was loss of employment for affected employees.
Implemented Management Practices	Needed PBC provided severance pay, offered to make introductions and serve as references, and extended the terms of their equity options so that they had 2 years to exercise after the layoffs as opposed to the standard 3 months.
Other Management Comments	At the time, the team was positioned to support amplification/scale versus making manufacturing/operational improvements. Accordingly, the lay-offs became necessary to extend the runway and give us more time to ensure the survival of our business. This was a hugely difficult decision (Needed had hired fantastic people, albeit prematurely), but the right path forward for the company. The team continued to operate as a full-time team of two (just the two founders) since November 2019 and just started to hire in 2022 after seeing success in the last year.
