This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

DISCLOSURE QUESTIONNAIRE CATEGORY	Significant layoffs of >20% of workforce
ISSUE DATE	March 2020
TOPIC	Significant layoffs due to COVID-19.
SUMMARY OF ISSUE	Due to the COVID-19 pandemic in March 2020, the company claims that it was necessary to lay off and furlough team members. The affected employees filed for unemployment in their respective states of employment. 2 employees got under furlough, representing 13.3% of the team. The company reports that the remaining team members took 15% pay cuts, executives took 25% pay cuts, and the founder took a 100% pay cut.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	4 employees were laid off, representing 26.6% of the company's employees at that time.
IMPACT ON STAKEHOLDERS	Primary impact was loss of employment for affected employees.
IMPLEMENTED MGT PRACTICES	The company reports that employees were paid through the end of the month of March. The severance pay equal to 1 month of pay and 3 months of healthcare coverage was also paid out upon layoff. For furloughed employees, the company maintained and fully paid for their health insurance throughout the furlough period. Letters of recommendation were offered to all team members.
MANAGEMENT COMMENTS	The company reports to have offered a job back to 1 furloughed employee, who accepted and rejoined the company in August 2020. Additionally, in 2021, the company hired back 2 laid off employees.
