Topic	Disputes related to workplace-related injury compensation.
Summary of Issue	Ningbo Liangyuan Packaging Solution Technology Co.,Ltd. has a total of two material labour arbitration cases which are pending resolution.Of the two cases that went to arbitration mediation, one case was related to the payment of adequate compensation for injuries sustained at work.The other case was about an employee compensation claim for injuries sustained in a traffic accident involving another person on the way to work, by using the workplace injury fund process, as the employee was unable to receive civil compensation.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	Update: Both arbitration cases have been settled through mediation. 1. Liangyuan compensated the party involved with a sum of CNY 115,000 (equivalent to USD 15,500). 2. The compensation amount was CNY 70,000 (equivalent to USD 9,500).
Impact on Stakeholders	The affected stakeholders are the employer and the related employee(s).
Resolution	The arbitration cases resolution are still pending in the District Labour Arbitration Court.
Management Practices	The company has a Workplace injury insurance benefit that covers all employees for injuries sustained at the workplace.
