Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Issue Date	2021 - 2025
Topic	Litigation, Arbitration, and/or Penalties related to labor issues & workplace injuries
Summary of Issue	In the past 5 years, the company has had two class action cases related to wage and hours disputes and two cases related to workplace injuries. Class actions: One case has been settled against the company with payment due to the regular rate of pay and recalculation of overtime. The remaining case is related to compliance with California wages & hours and is currently pending. Workplace injuries: A third-party janitorial service was hired to clean up debris from Torani's production facility. An employee of that janitorial service was injured. The case was settled with payment via the insurance. An employee was injured at work and subsequently placed on modified duty. When the employee was unable to continue performing their role, Torani terminated their employment. The employee later filed a lawsuit alleging wage and hour violations, which became a class action after another employee joined. The case was settled with a payment.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	Class actions: The settled case represents less than 1% of the company's revenue. The pending case does not have an established value yet. Workplace injuries Both cases have been settled with an overall payment of less than 1% of the company's revenue.
Impact on Stakeholders	The primary stakeholders impacted were current and former employees, as well as outsourced contractors.

Resolution	Class actions: One case is settled against the company with payment, and the other is currently pending a final resolution. Workplace injuries: Both cases were settled with payment
Management Practices	The company received training on how to calculate the regular rate of pay and overtime properly, and works with the employment counsel to ensure ongoing compliance. The company has implemented checks and controls to keep compliance with wage & hours. This process helped the company to correct the date ranges related to bonuses. Torani has ensured their processes are in place to prevent any further claims.
