

DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

TOPIC	Company sells precious metal jewelry
SUMMARY OF ISSUE	MRK Fine Arts is a jewelry retailer whose products utilize precious metals and gemstones raw materials that could be considered conflict minerals pose a potential human rights risk. In an effort to ensure conflict-free sourcing of their raw materials:
	 97% of the company's precious metals (gold and silver) are sourced from Responsible Jewelry Council Certified suppliers (RJC certified). The remaining 3% comes from a supplier assured by the London Buillon Market Association (LBMA assured). Diamonds represent 5% of the company's overall raw material expenses. 80% of diamonds sourced by the company are covered by RJC certification. The remaining 20% are covered by the Kimberly Process Certification Scheme. Emeralds and rubies are rarely sourced by the company, but when purchased they are compliant with the Jade Act which prohibits sourcing from Burma.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Approximately 90% of the company's Cost of Goods Sold comes from raw materials that would be considered a high risk for human rights violations, including gold, silver, diamonds, and other gemstones.
IMPACT ON STAKEHOLDER(S)	The use of precious metals and gemstones poses a human rights risk due to the possibility that they are sourced from conflict-affected and high risk areas, where they may be used to finance conflict and/or be associated with human rights abuses in the supply chain.
IMPLEMENTED MGT PRACTICES	In addition to the supplier certifications listed above, MRK Fine Arts visits its factories in person at least once a year. The company conducts a supplier assessment as well as provides its supplier code of conduct to all suppliers, which requires all diamonds be accompanied by a Kimberley Process Certificate.
