Disclosure Questionnaire Category: Others - Clients in Controversial Industries

Topic	Clients in Controversial Industries
Summary of Issue	Hammerfest is a marketing firm that has ongoing work with two brands managed by the Dutch State Lottery, an organization that reinvests profits back to society through charities and Sports Foundations. The service offered to these clients was the development of marketing campaigns and content; a service that can be offered to both clients in controversial as well as non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In the current FY2023, clients in the Charity Lottery industry represented 16.5% of the company's total revenue. Revenue from this client in FY2022 represented 26.2%.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry.
	B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	The company has worked with any other clients operating in a controversial industry except for Charity Lotteries.
	Hammerfest has a position on working with companies operating in the Fossil Fuel Industry and has discontinued work with an airline as a result of this. As part of this commitment, the company also joined a local initiative named 'Fossiel no deal,' which aims to be an advocate for change in the Dutch advertising industry and to inspire agencies not to work anymore for the fossil industry.
	Hammerfest is working on a long-term campaign for NGOs emphasizing the negative effects of alcohol consumption and



have also decided not to work anymore for alcohol brands.

Moreover the company has been working on a long-term campaign for NGOs against the tobacco industry and have signed an official agreement with these NGOs that Hammerfest will under no circumstances work for the tobacco industry.

When Hammerfest receives a new request from a prospective client, they conduct desk research on their activities and policies in relation to sustainability. Any concerns are raised during the introductory meeting with the potential client. New prospects are discussed by the board to decide on whether to move forward with an introductory meeting. If sensitive issues or controversy are detected, the company evaluates the client and industry risks against their mission: to create a more inclusive tomorrow through the work they create for their

clients. The company is not open to working with any company
