| IMPACT ON STAKEHOLDERS | Agriculture poses a risk to local ecosystems of flora and fauna as well as the potential degradation of cultivated land. |
| IMPLEMENTED MGT PRACTICES | "Agrícola Andrea SAC carried out a quantitative biological baseline of each farm, where the negative impacts were quantified for the surrounding flora and fauna. This study was carried out by SGS del Peru, a consulting firm duly authorized by the competent environmental authority for the sector. |
| | Although the flora is located far from the crops, the company identified that possible negative impact could affect the local flora though pruning, manual thinning and impaling activities due to inappropriate practices of the workers generating the clearing of the vegetation. However, their company complies with the following commitments: |
| | Maintenance of living fences Training of workers on the management of flora and fauna species in the area, as well as on caring for the environment. |
| | They identified the possible negative impacts for the local flora, through the various activities carried out by the workers that will generate an increase in noise levels, generating the alteration of the habitat; However, they have noted that the local species are are adapted to this environment; the registered bird species are NOT in the category of threatened species (S.D. No. 004-2014-MINAGRI). Additionally, they are committed to: |
| | Implement posters in the Fundo's facilities with messages "hunting forbidden". In desert areas where the presence of foxes has been identified, drinkers have been installed in order to preserve the synergy of our operations with the environment. | IMPACT ON STAKEHOLDERS | "As a water intensive industry, agriculture poses risks such as water stress or depletion of local water sources if water use is not appropriately managed. The company uses the subsoil water resource, for which they have groundwater use licenses issued by the competent authority. Likewise, they have a license for the surface water of lakes for one of their farms. The National Water Authority (ANA) is the regulatory entity, which supervises their consumption, as well as their statements of use. In order to be granted a license by the National Water Authority (ANA), they supervise that the water demand of each administered is adequate to the water supply, without putting the area of influence at risk." |
| IMPLEMENTED MGT PRACTICES | "The company operates its farms in the department of ICA, an area declared closed by the National Water Authority. The National Water Authority determined the prohibition of drilling new wells or execution of any type of work destined to the extraction of underground water resources, the increase in extraction volumes, the granting of authorizations for the execution of works, or rights to use groundwater, even in the case of applications in the process of regularization. |
| | Agrícola Andrea has the respective licenses for the use of groundwater. They use technified irrigation (drip irrigation), which optimizes the amount of water given to each plant, working with an irrigation efficiency of 95% in each of their farms. As part of the environmental certification of their farm, they are required to gain favourable technical opinions from the ANA based on detailed calculations of water use. |
| | Each farm has reservoirs that allow adequate storage of water. In turn, their crops are characterized by sowing in spaced rows, considering activities such as weeding, which breaks the surface crust, interrupting the capillary rise of water, preserving the water resource in the soil, thus also contributing organic matter to their soil helping it to improve the hydric capacity of the soils and also the infiltration of water. |
| | Among their operational objectives are: |
| | Provide preventive maintenance to irrigation systems (pipes, valves and hydraulic connections) and reservoirs, in order to avoid potential losses of resources. Train their staff in the efficient use and management of water resources, valuing its importance as a source of life. Monitor groundwater. Train staff on the means of soil and water contamination, as well as how it affects agricultural development.
