

DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	The company works with some companies in controversial industries. Nature is a strategic insights consultancy and the services they provide to the clients in the controversial industries are also available to other clients. The rates charged are the same in controversial and non controversial industries.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Fossil Fuel Industry represents 4% of their total revenue for FY21. Gambling Industry represents 2.2% of their total revenue for FY21. Alcohol Industry represents 2.3% of their total revenue for FY21.
IMPACT ON STAKEHOLDERS	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry.
IMPLEMENTED MGT PRACTICES	Nature declares to have chosen not to work for clients where there is a clear risk of harm, to either people in their community or the environment. Where they work with clients that operate in sensitive industries, Nature claims to employ a careful process for evaluating the projects that they undertake. This ensures that the basis and outcome of these projects meets their standard of ethics, corporate responsibility and fairness, and that these projects are unlikely to result in negative social outcomes. They also prioritise working with clients in these industries where their work will have a positive social and environmental impact.
	All new clients that operate in sensitive industries, which include but are not limited to alcohol, gambling and fossil fuels, need to be approved by a Partner before Nature will undertake any work. This approval process involves an assessment of the client's commercial strategy, business operations, CSR initiatives, and their track record of performance on these issues. The same process exists for current clients of Nature, if the company becomes aware that client organisations have behaved in a manner inconsistent with their standards and internal policies.
	Nature has also set targets to reduce the work undertaken in sensitive industries. In some cases this may involve no longer working with certain clients, and in other cases it will involve continuing to change our mix of projects with clients in these industries to be more focussed on positive social and environmental outcomes. Nature has the established the target to reduce their revenue coming from controversial industries to 5.6% by 2023 and <5% by 2024.
