SUMMARY OF ISSUE	Walden Local Meat's supplier farmers raise animals on pastures that are herbicide and pesticide-free and do not administer antibiotics or hormones.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Walden Local sources from 56 farms from New York and New England. The average herd size for pigs is 150 and the average herd size for beef ranges from small producers with 30-50 heads of beef to farming partners with an average herd size of 150.
IMPACT ON STAKEHOLDERS	Walden Local Meat requires that suppliers sign affidavits with criteria related to animal welfare, including no bodily modifications such as tail docking, beak trimming, or nose rings, humane handling practices to be employed during transportation and prohibit the use of electric prods or overcrowding. A USDA agent is on site at Walden Local Meat's processing facility at all times to ensure that farmers remain affidavit compliant. Both routine and surprise audits are performed across all of supplier farms to ensure that requirements regarding best in class animal welfare practices are being followed.
IMPLEMENTED MGT PRACTICES	"Template affidavits are made publicly available on Walden Local Meat's website (see below). Walden Local Meat has committed to adding to its existing farmer verification and audit system an animal welfare certification recognized by the ASPCA® Shop With Your Heart program by 2020 across all four of our proteins: beef, pork, lamb and chicken. New farmers are given a 12 month period to undergo certification recognized by the ASPCA® Shop With Your Heart program.  By 2024, Walden Local Meat has a commitment to match or better GAP's standards (for example, on space per bird, lighting, litter, and enrichment) and require that birds are processed using a multi-step controlled atmosphere processing system that's widely hailed as more humane, and verify using third-party auditing. Walden Local Meat employs 3rd party Earthclaims LLC to work with supplier farmers to help them achieve GAP 4+ certifications. For farmers who are not GAP certified, Walden Local Meat has contract stipulations regarding improving animal welfare practices overtime."

IMPLEMENTED MGT PRACTICES	"The company requires all of their partner farmers to employ regenerative agriculture practices, including but not limited to rotational grazing on herbicide and pesticide free pastures. The impact of this type of farming has been shown to be a net-positive to biodiversity.  They require all of their partners to employ rotational grazing practices, which have been scientifically proven to improve biodiversity. They audit all of their partners on a regular basis, both scheduled and unscheduled, to ensure that they are in fact farming in a way that supports the overall ecosystem and biodiversity. They promote a diverse array of feed options allowing farmers to have varied fields that themselves promote a more diverse array of animal and plant life.  They believe that by increasing the overall acres in perennial pasture year over year that they are helping to preserve and conserve biodiversity. They track acres in perennial pasture on a yearly basis and their intention is for the number to increase each time they take a measurement."

They are working on getting an overall benchmark for reduction with a study that they are doing with a Columbia Graduate student measuring their overall carbon output."
