SUMMARY OF ISSUE	As a real estate developer, Domofrance operates in an industry that is energy and emissions intensive.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Approximately 93.6% of Domofrance revenue comes from real estate development of new structures.
IMPACT ON STAKEHOLDER(S)	Decisions made in the real estate development and design process—such as appliance selection, building energy efficiency, construction materials, and energy source availability—impact the long-term energy and emissions performance of the structure.
IMPLEMENTED MGT PRACTICES	Domofrance aims to improve its practices and results in order to reduce energy consumption and reduce the carbon footprint of its buildings and operations. They have invested € 700 million over 10 years in refurbishment (15% reduction in the energy consumption of each dwelling) and compliance with the future RE 2020 energy regulations, to be applied in 2021 (regarding lower energy and lower CO2).
	They operate a sustainable purchasing plan for customers and comply with the ISO process, materials, and carbon footprint. They are ISO 50001 certified, and they also have NF Habitat, HQE (high environmental quality) certification. The company employs continuous improvement. They follow the evolution of energy consumption and expenditure for tenants, which has an impact on their rental charges.
	The company has set a 15% reduction target for energy consumption and to develop renewable energy with photovoltaics and solar in their programs, infrastructures, hydrogen boiler and urban microalgae depolluting farms.

SUMMARY OF ISSUE	As a real estate developer, Domofrance operates in an industry that is water intensive.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Approximately 93.6% of Domofrance revenue comes from real estate development of new structures.



IMPACT ON STAKEHOLDER(S)	The construction of buildings requires large quantities of water (concrete, cement). Customers also contribute to levels of water consumption in residential and office buildings and shops. The water used for the construction and use of buildings (and housing) reduces the available resource for the entire population, for other businesses and for agriculture. The company sources water from the Bordeaux Metropole.
IMPLEMENTED MGT PRACTICES	The company has set up compulsory charters for low risk sites for their suppliers. They also replaced concrete construction with wooden construction, for example they have built 400 student housing units in Pessac in modular timber from an Ossabois company which uses wood from forests managed in a sustainable manner. They also educate their tenants on eco-friendly practices to preserve resources and reduce bills through regular sessions in groups, information to all by extranet and permanent reminders, especially during the summer months. They are also increasing the number of approved water
	meters to precisely measure consumption and of course reduce it.

TOPIC	Domofrance has their HQ located in a sensitive ecosystem
SUMMARY OF ISSUE	Domofrance has their HQ located in the marshlands of the Bordeaux Lac, which was built in 1977. They also built a company restaurant on the same site in 2013.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	The company has one facility (their HQ) located in a sensitive ecosystem.
IMPACT ON STAKEHOLDER(S)	Potential risks from operations located in sensitive ecosystems include damage to local environments from human and mechanical impacts, as well as indirect impacts from land conversion use and risks to flora and fauna.
IMPLEMENTED MGT PRACTICES	The Company HQ was built before there was legislation on protecting biodiversity in the area. They do not conduct any construction practices in the surrounding area of the HQ. Since 2018, a law has been passed which ensures that businesses Avoid, Reduce or Compensate any damage caused to the environment (ERC rule). The company also has formal bans on any construction in protected areas and penalties for constructing in sensitive areas, with the obligation of compensatory actions to restore protected species (plants, animals etc.) If a company violates this law, they can be ordered to provide compensation for the next 30 years. Domofrance has never received any such violations. When undergoing any new construction for their clients, the company identifies any sensitive areas and design to avoid any conflicts. They also have an agreement with an external Biodiversity Organisation (CDC Biodiversité) which organizes compensation actions in natural areas. They agreed a 3-year agreement (2018 - 2020) with the company to provide annual compensation for training and awareness-raising of development and promotion teams on these subjects. They plan to continue this work with another organisation moving forward.
	They are also experimenting with soil remediation by fungi to preserve (on the adjacent land) a watercourse and a future rainwater reserve at a sensitive location in Pessac.
