Disclosure Materials

Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

B Lab's Public Complaints Process

Any party may submit a complaint about a current B Corp through B Lab's Public Complaint Process. Grounds for complaint include:

- 1) Intentional misrepresentation of practices, policies, and/or claimed outcomes during the company's certification process
- Breaches of the B Corp Community's core values as expressed in our Declaration of Interdependence

Issue Date	September 18, 2025
Topic	Company has filed for bankruptcy
Summary of Issue	In June 2023, AeroFarms declared Chapter 11 bankruptcy to undergo restructuring. The filing significantly impacted stakeholders, particularly employees, with an estimated ~50% reduction in the corporate workforce. The most heavily affected groups were the R&D team and staff located outside the United States. Suppliers and investors were also affected, but the brunt of the impact was borne by the workforce. This was the first and only bankruptcy filing by AeroFarms. Since then, the company has restructured its operations with a more focused approach on domestic, commercial growing, which has allowed it to become economically viable and better positioned to avoid similar financial distress in the future.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	~50% of the workforce affected
Impact on Stakeholders	Suppliers and investors were also affected, but the brunt of the impact was borne by the workforce.
Resolution	The company has restructured its operations with a more focused approach on domestic, commercial growing, which has allowed it to become economically viable and better positioned to avoid similar financial distress in the future, This is the only time AeroFarms has declared bankruptcy.
Management Practices	With a more focused approach on domestic, commercial growing, AeroFarms is now an economically viable company.
