TOPIC	Aires de Campo is a company in the wholesale/retail industry and is retailer of organic food products. The company sources >50% of their supplier expenses from animal farms
SUMMARY OF ISSUE	The company sources from local farms. Specifically, they purchase from 3 pasture farms and 3 meat farms. The farms are certified organic, so the production follows the Mexican organic standards, which includes free grazing.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	The company sources from one egg farm in Morelos, with a capacity 30 thousand hens per farm plus its recreation area. The company sources meat from chicken farms, two located in Morelos and one in Veracruz, with an average capacity of 39 though chickens per farm plus recreating area.
IMPACT ON STAKEHOLDERS	"Aires de Campo complies with the national regulations in Mexico on animal welfare and are in the process of obtaining the Certified Humane standard for animal welfare. the international standard of animal welfare. The company complies with organic standards, as the have the Mexico Organic Certification (Ley de Produccion Organica) for all of their products, and thus are complying with more than 60% of the animal welfare certification, since some animal welfare standards are built into organic.
	The hens and chickens are kept free of cages, there are some characteristics for the correct development of the animals, such as hangers to encourage the flight and mobility of their wings, they have grazing areas to exercise and to peck/pastorate in green areas, and they must have at least 8 hours of rest.
	All of the company's farms have organic certification where confinement in cages is prohibited, and other indicators several indicators of animal welfare are also taken into account such as: hangers, requirement of free grazing and recreational areas with grass and shade, bed with rice husks, etc All farms are in the process of implementing the global animal welfare standard, set by the Humane Society, which is being sought by 2023. They have two farm inspectors who monitor this program (veterinarian and animal production engineer).
IMPLEMENTED MGT PRACTICES	They have set the target for obtaining the Certified Humane animal welfare certification for all farms in 2023. They also work with the Humane Society International and the Mexican Secretary of Agriculture, which also regulate animal welfare issues through standards of good livestock practices and biosecurity.

SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Approximately 63% supplier expenses come directly from animal farms.
IMPACT ON STAKEHOLDERS	Animal agriculture poses a risk to local ecosystems of flora and fauna as well as the potential degradation of farmed land.
IMPLEMENTED MGT PRACTICES	"The company has the organic certification for their products, and it has been proven that organic production helps preserve biodiversity starting with pollinators. For example, in the production of their organic honey, there can be no contamination from gas stations or agrochemical fertilizers or pesticides at least 6 km in diameter around the world because the #1 cause of bee death is agrochemicals. The use of pesticides, fertilizers, sewage, burning of waste or soil, and all other substances that are marked by the Organic Production Act LPO, is prohibited, and Aires de Campo only works with certified organic producers. At this time, the company does not have specific targets related to the conservation of biodiversity on farms. They have an agricultural supervisor who trains and determines sustainable best practices (aligned to organic production) that poultry feed producers will use. They do not have specific training programs or support for biodiversity management of the farms. "

SUMMARY OF ISSUE	As a retailer of organic foods and a company who purchases direct from animal farms, Aires de Campo operates in an industry that is water intensive.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Approximately 63% supplier expenses come directly from animal farms.
IMPACT ON STAKEHOLDERS	As a water intensive industry, animal agriculture poses risks such as water stress or depletion of local water sources if water use is not appropriately managed. The company's suppliers primarily use spring water, depend on surrounding communities. They do not operate in water stressed regions.
IMPLEMENTED MGT PRACTICES	Currently, on farms the water consumption was 6.7 liters per chicken. To date, the company has not implemented practices to minimize water consumption and do not have specific objectives for reducing water consumption on the farms they source from. 89% of chicken feed is produced using rainwater and other natural sources, while only 11% is irrigated. In 2023, the company has plans to better track water usage on the farm and to identify services or processes to be able to make plans to reduce consumption.

IMPACT ON STAKEHOLDERS	Animal agriculture is a major contributor to global carbon emissions.
IMPLEMENTED MGT PRACTICES	The company is tracking total energy usage at the farms. The annual kWh data from both chicken and egg farms is 73,200, for a monthly average of 6,100 kWh. The gas consumption is only tracked at chicken farms, as the egg farms do not use gas, and the annual usage is 202,800, which is an average monthly consumption of 16,900. At this time, they do not have established reduction targets related to energy usage and emissions for the farms that they source from.
