## **Disclosure Questionnaire Statement**

Disclosure Questionnaire Category: Facilities located in sensitive ecosystems

Topic	Coöperatie De Droomfabriek U.A. is a consulting/strategy company and their facility is located in a Natura 2000 Ecosystem part of De Veluwe.
Summary of Issue	The company has an office in Natura 2000 which is a network of protected areas covering Europe's most valuable and threatened species and habitats. It is the largest coordinated network of protected areas in the world, extending across all 27 EU Member States, both on land and at sea. The sites within Natura 2000 are designated under the Birds and the Habitats Directives.  There are over 27 000 nature sites protected by EU legislation. These form the Natura 2000 network.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	The company only has one office. Hence,100% of the company's facilities, in terms of area, are located adjacent to a sensitive ecosystem.
Impact on Stakeholders	Having facilities/operations near protected/sensitive ecosystems can potentially impact the flora, fauna and quality of the ecosystem (e.g. noise & light pollution from the facilities, spills, air / soil / water pollution owing to the company's operations).
Implemented Management Practices	Since November 2023, the company's clients can only enter the protected area on foot or by bicycle. Bicycles are provided for free to cycle from a central parking lot, which is outside the protected area, to the company's location.
