The Director of the company has taken a course to get a personal licence which is around safety of selling alcohol. When alcohol is sent out for deliveries the company has a ""verify 18"" signature that the receiver has to prove they are over 18 to accept the delivery. On site sales have an over 25 verification process implemented. Physical bottles of gin have the do not drink if you are pregnant symbol as well as how many UK units are in a bottle for safe measuring."
