Disclosure Questionnaire Category: Operations located in Conflict Zones

Topic	Company operates in Conflict Zones
Summary of Issue	Environment Systems Limited works for the UK government and international development banks to understand the food security situation on the ground in conflict zones. The company uses satellite mapping to identify where crops are being grown for consumption. This data is used to focus on humanitarian aid as needed. We do not go into these countries, as all work is desk-based. The company remotely develops this work on in Yemen and Ethiopia, considered conflict zones, and in Libya and Venezuela, considered countries with institutional and social fragility per the FY24 List of Fragile and Conflict-affected Situations (World Bank)
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	Approximately 3% of the company's revenue came from satellite mapping done remotely in those regions.
Impact on Stakeholders	Business activities developed in conflict zones are considered high-risk as they are more likely to cause or contribute to the conflict and/or sociopolitical instability. As per the OECD, conflict zones are often characterized by widespread human rights abuses and violations of national or international law. Countries classified as conflict zones are more likely to have a weak rule-of-law or a corrupt judicial system, which could undermine the effectiveness of operational grievance mechanisms for these businesses and their suppliers. In addition, the safety of the company's workers and other potential human rights violations are at risk.
Implemented Management Practices	The company reported the following practices to address the risks mentioned above: • There is an anti-corruption and bribery policy in place as part of the company's standard suite of company policies, • It has an employee-run ethics committee that provides scrutiny on work undertaken by the company,

	• It only works for third parties (such as NGOs and the UK government) operating in conflict zones, not local/regional governments or armed bodies.
