TOPIC	Two OSHA complaints regarding COVID-19 safety measures
SUMMARY OF ISSUE	AllCare Health received two formal notices from the Oregon Occupational Health and Safety Division regarding the enforcement of social distancing and mask wearing protocols onsite.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	There have been no fines or penalties issued as a result of these complaints. At the time of the complaints, approximately 15% of employees were still working onsite, and the remainder had transitioned to remote work.
IMPACT ON STAKEHOLDERS	The complaints submitted to OSHA alleged that some areas of the workplace did not have adequate spacing of 6 feet between employees, and that social distancing and mask wearing policies were not being properly adhered to.
IMPLEMENTED MGT PRACTICES	AllCare formed a Business Continuity Management Team (BCMT) on March 4, 2020 to help mitigate the hazards of COVID-19 to employees and members. The BCMT immediately created an infectious disease policy and met daily throughout March to continually update AllCare's protocols in alignment with guidance from the CDC, OHA, and county and state officials. Safety procedures included allowing most staff to work from home, supplying hand sanitizers and other hygiene supplies to employees, ensuring seating was positioned at least 6 feet apart, creating and distributing a Universal Masking Policy, increasing the ventilation rates for HVAC systems, and increasing water flow to ensure effective handwashing. In response to the second alleged hazard, an investigation team conducted several inspections of the workplace to ensure employees were following the relevant policies. This was in addition to twice daily checks performed by the physical distancing officer to ensure full compliance. The investigation made one adjustment to desk arrangements to ensure all employees were beyond the required six feet. In addition, the company placed additional face mask signs and planned additional trainings for employees.
