## **Disclosure Materials**

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

#### **B Lab's Public Complaints Process**

Any party may submit a complaint about a current B Corp through B Lab's Public Complaint Process. Grounds for complaint include:

- 1) Intentional misrepresentation of practices, policies, and/or claimed outcomes during the company's certification process
- Breaches of the B Corp Community's core values as expressed in our Declaration of Interdependence

Topic	Clients in Ineligible Industries
Summary of Issue	The Team has clients in the following industries: Fossil Fuels. The types of services offered to these clients include:  • Brand strategy, digital design.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In the last fiscal year, 4.29% of the company's annual revenue was from clients in the Fossil Fuel industry.
Impact on Stakeholders	Companies that work with clients in controversial industries can directly or indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry.
	Companies offering certain types of services and products to controversial clients are required to have at minimum a grievance/complaints mechanism and a whistleblower protection policy.
Implemented Management Practices	The Team has the following mechanisms in place to manage the risks associated with serving clients in the controversial industries:
	Grievance/Complaints Mechanism. This is accessible to the public through a Grievance Form available on the company's website. Once a grievance is submitted, the company acknowledges its receipt and conducts an initial review to assess the validity and seriousness of the complaint to determine whether further investigation is required. The company arranges a grievance meeting, normally within 10 working days of receiving the complaint. The complainant will be informed of the outcome and any next steps within two weeks of the final grievance meeting. If the complainant is dissatisfied with the resolution, they may appeal within 10 working days. The company will confirm the final decision in writing, within two weeks of the appeal hearing. This is the end of the procedure, and there is no further appeal.



	Whistleblower Protection Policy. The Policy includes the company's commitment to protecting whistleblowers from retaliation. Retaliatory actions will result in disciplinary measures. Implementation of this policy is continually monitored and is reviewed on an ongoing basis to reflect changes in the law, best practice, business requirements, and feedback received from staff, clients, and other stakeholders. This policy covers all employees, officers, consultants, contractors, interns, casual workers, and agency workers, but also extends to all stakeholders who feel a need to raise a concern, grievance, or complaint about the activities of the Company.
