TOPIC	ComBio supplies renewable energy for industries involved with mining, alcohol, and agribusiness.
SUMMARY OF ISSUE	ComBio offers steam production outsourcing service to other industries, using biomass as fuel. Their business model promotes the migration of their customers' energy matrix, switching from fossil fuel to renewable fuel in their boilers.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In 2020 clients in the mining industries accounted for 69% and clients in the brewery industries accounted for 8%. The customer pays only for the steam consumed.
IMPACT ON STAKEHOLDERS	The company's operation has an environmental gain for the customer by reducing their greenhouse gas emissions.
IMPLEMENTED MGT PRACTICES	The company's service is applicable to a variety of customers in the industrial sector as thermal energy is essential for the industrial process. The company works together with their clients to create tailor-made projects and their project team plans the operation to suit the customer's physical availability conditions (available space for the boiler). By the end of 2021, the company had three clients in the mining sector. ComBio works with them as part of their broader sustainability strategy. ComBio monitors these company's sustainability performance via their annual sustainability report. The company is also in conversation with their mining customers to create partnerships and jointly promote socio-environmental actions. The company contracts are long-term and set to an average of 10 years. The useful life of the boiler can reach 40 years, and they therefore, believe in the renewal of the contract and strive to maintain the boilers so that they maximize their life cycle. Among the client's responsibilities are the provision of an area for the installation of the boiler, water point and electricity point. All implementation issues (licensing, fundraising, purchase of equipment and works) and operation (payroll, boiler maintenance and biomass supply) are the responsibility of ComBio. The company adapts its boilers so that they can burn multiple biomasses, either alone or mixed with others. Traditionally biomass boilers are designed to receive only one input, with eucalyptus chips and sugarcane bagasse being the most widely used.

торіс	Company has one biomass facility located the Amazon Biome.
SUMMARY OF ISSUE	The company has an operation located in the Amazon biome, in Barcarena, Pará. In states where the issue of illegal deforestation is more sensitive, the company only purchases reforestation wood with the proper forest guides and following all the proper procedures. In these locations, they have a stricter control on the supplier profile and also conduct on site visits. ComBio also designed a machine capable of burning the açaí lump, which is generally discarded, generating a double environmental benefit: circular economy and transition to a cleaner energy matrix.
	In these sensitive ecosystem, government entities are charged with protecting and monitoring the region, such as the Ministry of the Environment with the ARPA Program – Protected Areas of the Amazon; the Brazilian Institute for the Environment and Renewable Natural Resources (Ibama); and the Chico Mendes Institute for Biodiversity Conservation (ICMBio). Recently, the Amazon Plan 2021/2020 was launched, which establishes guidelines for inspection actions and the fight against illegal deforestation, fires and other environmental crimes.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	One of the eight steam producing units is located in the Amazon biome, in the municipality of Barcarena, Pará. In 2020, this unit accounted for about 4% of the steam production and 6.7% of the company's revenue. The operation is located in the industrial and port region of the city, within the company client's plant.
IMPACT ON STAKEHOLDERS	Barcarena is in a region with high rates of illegal deforestation and therefore, the main risk is related to the purchase of raw material. The company also uses the açai lump as fuel, to reduce the amount of reforestation wood purchased in comparison with other ComBio operations.
IMPLEMENTED MGT PRACTICES	The company acquires wood loads only with the proper forest guides and following all the procedures for receiving and issuing the guides. Therefore, in these locations, they company has a more rigorous control of the supplier profile. The company has also ceased sourcing from suppliers after on site visits. For the selection of supplier forest plantation areas, ComBio considers the location, condition of mechanized harvesting and transport operation, acquisition cost, environmental liabilities, disputes regarding land tenure and other applicable legal requirements. Their legal team (outsourced) evaluates the property documentation and only proceeds with the contract after the legal approval.
	Regarding wood chips, the guidelines are for suppliers that work with reforested wood and of legal origin. With regard to other biomasses, such as rice husks, priority is given to purchasing directly from the mill, that is, at origin and without the presence of a middleman. Additionally, there may be a credit analysis in situations where there is advance payment, but this scenario is quite rare.

TOPIC	ComBio produces bio energy from Eucalyptus forests in Brazil.
SUMMARY OF ISSUE	ComBio has Eucalyptus operations in the State of Mato Grosso which is located in the Cerrado and in the State of Sao Paulo which is located in the Mata Atlantica.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In 2020, he company's own Eucalyptus production accounted for 52.6% of their Biomass. In addition to their own eucalyptus,they use different types of biomass considered by-products of agricultural, industrial and reforestation activities (rice husk, açai lump, sawdust, etc.).
IMPACT ON STAKEHOLDERS	B Lab has created additional Controversial Industry Standards for Agri Producers that operate in protected forests in Brazil. These include creating a No Conversion Policy with a cut off date of at least 1st of January, 2020 and a formal commitment to respecting land rights of indigenous peoples and practices such as identification and assessment of protected areas, indigenous lands and other areas of natural and cultural significance in the company's vicinity, dialogue and engagement with communities, grievance mechanisms for community members as well as evidence of having resolved any disputes in the past. As a Certified B Corp, ComBio will have one recertification cycles (3 years) to implement the above practices and comply with the new requirements.

TOPIC	ComBio produces bio energy from Eucalyptus forests in Brazil Cont.
IMPLEMENTED MGT PRACTICES	All of the company's leased farms or farms entitled to tenure are covered by long-term contracts. Currently, ComBio has two ways of acting in its forestry units. In the first model, they buy the already developed forest massif (standing forest) from the owners of farms/areas, carry out the processing of the eucalyptus and transport the biomass to our boilers. This group includes old, burned and damaged forests, which would not have the commercial destination for which they were cultivated. As soon as the activities are completed, they return the clean area to the owner to proceed with a new planting. In the second model, started in 2021, they have forestry activities, where they lease the area and carry out all stages of forest management (soil preparation, pest control, planting, irrigation, mowing and replanting). At the moment, they only have young forests of a maximum of 1 year.
	Regarding areas for eucalyptus cultivation, they request some standard documentation from the owners: ITR, deed, operating license - if applicable - and other applicable environmental documents. There is also a verification of the land in the registry offices to validate if the area is not embargoed, as well as environmental diligence which is carried out with consultation of the Ministry of the Environment lists, and to confirm that the areas that have not been deforested from 2010 onwards.
	ComBio is planning ways to have a closer relationship with the communities where it operates, with the aim of improving communication, carrying out projects and supporting local development. In 2020, they had their first and only communication regarding the flow of trucks transporting biomass on public roads in the city of Piedade, in the state of São Paulo, causing dust to be suspended. As soon as the communiqué was received, the lead employee of the operation went to the City Hall to talk to the Secretary of Works. The parties agreed to send trucks with crushed stone and compaction equipment to avoid raising dust on the road. Finally, ComBio already has an Ethics Channel with mechanisms to receive and forward reports of facts considered inconsistent or in disagreement with our Code of Conduct, values and/or the legislation itself. The channel is open to internal and external audiences, who can contact the Ethics Channel via the website, mobile app or telephone.
	Internally, they are also mobilizing to structure actions to achieve the Net Zero Commitment, which includes the purchase of electricity from renewable sources and the prospection of suppliers of electric wheel loaders, as well as reducing their consumption of fossil fuels. In addition, due to the significant reductions in emissions from their operations, ComBio's projects allow the generation of carbon credits, which are shared between the client and the company. The credits generated can be used to offset residual emissions and/or those that do not yet present viable alternatives to avoid them, for example, emissions from air conditioning. The company have published their GHG emissions inventory since 2014 in the Public Emissions Registry of the Brazilian GHG Protocol Program. In 2014 and 2015, the inventory was awarded the Silver Seal. As of 2016, it began to be audited by a third party, winning the Gold Seal. Currently, their inventory includes the impact of their direct emissions (Scope 1) and indirect electricity emissions (Scope 2). TOPIC	ComBio supplies renewable energy for industries involved with mining, alcohol, and agribusiness.
SUMMARY OF ISSUE	ComBio understands that the work category of their employees is not represented by any existing labor union in the region of Guaíba. Giving that, the company made a colective deal with the National Confederation of Workers in Guaíba/RS to represent their workers. However, in September 2021, the Union of Workers in the Pulp, Paper, Cardboard, Artifacts, Cork Industry of Guaíba (SINPACEL) filed a declaratory action against ComBio requesting recognition that SINPACEL should be representing ComBio's workers.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	All employees from ComBio are affected by the framing of their working category in collective deals and labor union representation.
IMPACT ON STAKEHOLDERS	Labor unions are important in the advocacy and defense of workers rights and interests.
RESOLUTION	The case is pending.
IMPLEMENTED MGT PRACTICES	ComBio understands that there is no local Labor Framework in Guaíba/RS applicable for ComBio 's workers. Since the ComBio's client workers in Guaíba/RS are represented by Sinpacel, this labor framework union understands that ComBio workers should also be represented by Sinpacel. From the understadning of ComBio, under the Brazilian Labor Law, the applicable union framework is defined by the predominant activity of the Employer on a territorial basis where the services are rendered. ComBio's main activity in Guaíba/RS (and nationally, regarding ComBio's operations in the Southeast, West, North and Northeast regions of Brazil) is Production and distribution of steam, hot water and air- conditioned, which do not relate to the activities represented by Sinpacel (Union of Workers in the Pulp, Paper, Cardboard, Artifacts, Cork Industry of Guaíba/RS, South of Brazil).
