

DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

TOPIC	Company produces pet food products containing seafood
SUMMARY OF ISSUE	Lily's Kitchen is a pet food company that sells some products that contain seafood ingredients, either as the primary protein or secondary ingredient.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Approximately 12% of the company's SKUs on a revenue basis contain seafood, and approximately 5% have seafood as the primary protein.
IMPACT ON STAKEHOLDERS	There are several social and environmental risks associated with the global seafood industry, including poor labor conditions, human rights violations, impacts on biodiversity, and impacts on ocean health. Supply chain traceability in the seafood industry is challenging, which contributes to the continued prevalence of these issues globally.
IMPLEMENTED MGT PRACTICES	Lily's Kitchen conducts a raw material traceability analysis for any new seafood raw materials via a review of its suppliers' Certificate of Origin, and the company prefers to source from suppliers located locally to the manufacturing site. The company also regularly monitors industry supply chain risks on an ongoing basis, including alerts via the Pet Food Manufacturers Association (PFMA), Rapid Alert System for Food and Feed (RASFF), and the quality team at Nestle Purina. Approximately 43% of its SKUs in which seafood is the primary protein are made with MSC certified seafood.
