Summary of Issue	Cytoplan Ltd is a UK based company which manufactures and sells products made with CBD: - CBD oil from hemp - CBD Warming Gel
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In 2024, less than 0.16% of the company's revenue was from sales of CBD related products.
Impact on Stakeholder(s)	Cannabis-related products are subject to controversy both because of their current and historic legal status around the world, as well as concerns about the potential harm that the products may cause. Current regulations governing the legality of cannabis-derived products are complex and vary widely by local jurisdiction.
Implemented Management Practices	UK CBD based products have novel food status and are regulated by the FSA (Food Standards agency). Cytoplan Ltd's products are free of controlled substances and contain less than 0.3% THC, complying with all applicable regulations in the UK. The company has provided their products' Certificates of Analysis showing compliance with the levels of THC. The company is not involved in the sale of medicinal nor recreational marijuana products.
