Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Disclosure Questionnaire Category: Disclosure Industries

Topic	Clients in Controversial Industries
Summary of Issue	KMC Community Inc. is based in the Philippines that leases office space staff to companies. Over the last 5 years, the company has leased properties on an on-going basis to companies operating in the Fossil Fuel, Pharmaceutical and Debt Collection Industries. KMC offers the same service to companies in controversial as well as non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In the 2022 fiscal year, the revenue derived from clients in controversial industries represented: - 3.14% from clients in the fossil fuel industry - 0.84% from clients in the pharmaceutical industry - 1.03% from clients involved with Debt Collection.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	The company has placed a firm KYC (Know your Client) requirement on all its client transactions. They do not engage with clients that are blacklisted based on The Financial Action Task Force (FATF) list; the global money laundering and terrorist financing watchdog. In addition, the company indicates that they exercise due diligence when evaluating potential clients operating in controversial industries by conducting an in-depth review of their business practices, compliance with regulations, and alignment with the company's values.
Management Comments	At KMC, we continuously strive to strike a balance between serving our clients and upholding ethical standards. While we remain open to working with clients from various industries, including those on the controversial client list, our due diligence process ensures that we approach these relationships with
